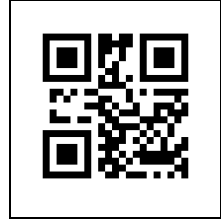
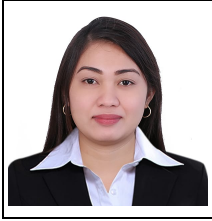

4. The waiting time at Application Center depends on the number of applications submitted at the counter by an individual.
5. Please be available at the Visa Application Center (VAC) 10 minutes prior to the scheduled appointment time in

your Appointment letter.

6.Family appointments can only be booked for husband, wife, son, and daughter. Any other relatives (e.g., cousins, uncles, grandparents) are not eligible for family appointments and will not be accepted. Please ensure you meet these criteria before proceeding with your booking.

7.Kindly refer to the checklist and carry documents as per requirements on the appointment date & time.

8.Due to security regulations, we don't permit Laptop, USB, Tablets, CD, Helmet and bags, and there is no storage space provided at our centre. Kindly make your own arrangements for safekeeping of your valuables. Please refer to Security Rules in BLS Website <https://kuwait.blsspainglobal.com/> for more information.

9.If the applicant is a first time traveler, biometric is mandatory and he/she needs to be present in person at the centre. Accompanying applicants will not be allowed to the centre except when accompanying children, differently abled or who need wheelchair assistance.

10.If you miss to turn up at our centre at the appointed date and time, BLS does not guarantee for a fresh appointment. You may have to seek a fresh appointment as per the availability online.
